3. This consent is given as an inducement for UME to use my Music Video and I understand UME will incur substantial expense in reliance thereof.
4. UME is not obliged to make any use of this Music Video or exercise any of the rights granted UME by this release.
5. I hereby warrant and represent that I have the full right, power and authority to grant UME and its assigns all of the rights provided in this release.
6. I agree to indemnify UME and its assigns from and against any damages, liabilities and costs incurred, arising out of inconsistencies my warrants and representations in this release.
7. I agree that this agreement shall be controlled by the laws of the State of California. In the event any dispute should arise between Odom Entertainment and the producer, we each agree to submit such disputes to exclusive and binding arbitration with the American Arbitration Association ("AAA"), and each shall bear his/her own costs, including attorney's fees, incurred in connection with any such arbitration.
8. I agree that this agreement shall be binding until a more formal and standard industry agreement is prepared and fully executed.
